- Exhibition** March 21 to June 21, 2026 in the Switzer Gallery.
- Media** Paintings, drawings, photography, ceramics, sculpture, digital art, glass, wood, and fiber/textiles.
- Eligibility** Artists 18 years and older, residing in West Virginia, Kentucky, or Ohio. Original works only, created by the artists themselves. All works must be the original expression of the artist and completed since 2024. Copied works and class work where assistance has been given are NOT acceptable. All works must be hand delivered, **no exceptions**.
- Presentation** Accepted work, excluding free standing pieces, must be **suitably framed** and wired for hanging. The museum reserves the right to eliminate works it deems unacceptable. Due to limited exhibition space, art work should NOT exceed 3 feet by 4 feet, **no exceptions**.
- Entry Information** Entry is \$40.00 non-members, \$30.00 members of TSAA. Each artist may enter up to 2 works of art. All entries must have a *completed entry form and labels* attached to back of each work.
- Prizes** Best of Show Award: \$400.00; First Place: \$300.00; 2<sup>nd</sup> Place: \$200.00; 3<sup>rd</sup> Place: \$100.00; Kathy Welch Memorial Award: \$100.00; Robert Hutton Memorial Award: \$100.00; Robert Cremeans Memorial Award: \$100.00; Carter Taylor Seaton Memorial Award: \$100.00; Honorable Mention/Ribbons, Purchase Awards.
- Sales** Every effort will be made to encourage sales of works. Works "Not for Sale" must be marked NFS. TSAA will process all sales and retain a commission of 20%.
- Insurance** All works accepted will be insured by the Museum during the exhibition period. Declare the value of NFS works for insurance purposes.

Jurying: Monday, March 9  
Opening Reception: Sunday, March 22, 2 pm – 4 pm

Selected artwork pickup: Monday, June 22, 10 am – 12 pm and 1 pm – 5 pm

The museum and TSAA will exercise usual care in handling entries, and are not responsible for ANY damages, thus all works are entered at artists' risk.*
